The regular meeting of the Hereford Township Board of Supervisors was held in person at the Municipal Building and via Zoom. Those present were Supervisors John Membrino, Keith Masemore, Assistant Secretary/Treasurer Louisa Masemore, Hereford Fire Chief Josh Borowski, Irene Donovan, Matthew Lorish and Larry Iampietro. Tom O'Conner, Patricia Ihenfeld, Jeff Ney and Candace Owens Reporter for Town and Country Newspaper attended on Zoom.

Mr. Membrino called the meeting to order at 7:31 p.m.

#### **Minutes**

Mr. Membrino made a motion and Ms. Dexter seconded to accept the February 7<sup>th</sup> Minutes. All were in favor. Motion carried.

### Payment of Bills and Approval of the Treasurer's Report

#### **Fire Companies**

**Hereford Fire Company-** Mr. Borowski reported 12 calls and gave the board a copy of their state grant. Mr. Membrino commented that their ISO seemed to have not changed. Mr. Borowski asked for a copy of the list of sworn in fire police members when the office was able.

**Seisholtzville Fire Company-** Mr. Strickland sent in a report of 9 calls. He reported soup sales are ongoing and dates and types of soup for sale are on the website. The adult bingo fundraiser is this week. They are proceeding with working on the 75th Anniversary celebration scheduled for Sept. 23. Several sponsors are on board all ready. They received a Pa. State Grant for \$14,808.81 which will be used to purchase some new gear and for debt reduction.

On another note, he said he was worried about the branch of the Perkiomen Creek behind his house. The board told him to fill out a complaint form. He noted that the heavy winds had not taken down any major trees. Mr. Masemore acknowledged that and thanked the citizens for
