Mr. Membrino called the meeting to order at 7:30 p.m.

### Minutes

Mr. Membrino made a motion and Ms. Dexter seconded to accept the August 1, 2023 All were in favor. Motion carried.

### Payment of Bills and Approval of the Treasurer's Report

Mr. Membrino made a motion and Mr. Masemore seconded to pay the bills and approve the Treasurer Report. All members voted in favor. Motion carried.

## <u>Personal Appearances</u> – No Report

#### Fire Companies

Seisholtzville Fire Company- Ms. Sacks reported 16 calls for the fire department in the month of July. For the month of August, they have had 14 calls so far since August 15<sup>th</sup> mostly consisting of tree clean up. Ms. Sacks would like to address the board concerning the decision on having the funding cut. Reports have been submitted monthly since Ms. Sacks was appointed Fire Chief, she is aware that there may not have been a member from the fire department at all the board meetings. She asked the board for a reason as to why the funds were cut and how having those funds cut would benefit the township. Mr. Masemore stated from his understanding, all the calls which Seisholtzville reported were handled by other departments. He also mentioned the number of staff members that arrived on scene was far fewer than the other departments that showed up to help assist. Mr. Masemore mentioned being the first responders on scene, you should not have delegated work to other departments. The board also was unaware that Seisholtzville Fire Department was being funded by another township. Mr. Masemore asked Ms. Sacks what her active number of members was, she stated there are 6 active members in her organization. Mr. Masemore wants to see them succeed, but he felt the money had to be taken to get their attention to the fact that the board wanted to have a conversation with them, and get them to attend the board meeting. Mr. Zajewski stated it's an issue with staffing not money, as a taxpayer he said it's a sense of community. He is aware that funds are being retracted, but he feels you cannot serve the community if the township takes the money. He believes it's more on the staffing interest issue not money. Ms. Dexter stated the struggle comes down to the lack of communication between the fire departments and how they work as a collective whole. Ms.

Dexter stated the other fire department on either end deserves an answer as to why you are not coming to the calls, it would be a courtesy. Ms. Dexter really appreciates having an updated spread sheet to show the improvement. Mr. Membrino mentions the letter from Longswamp, the fire department mentions they are working with Longswamp to get the contract back on track. Mr. Membrino mentions the importance of an audit, whether it is a formal audit or a spread sheet. The township requirement is whatever money is handed to the fire department from the township, it needs to be documented on how and when it is being spent. Any money given must be accounted for in a return format.

Hereford Fire Company- Mr. Borowski reported the fire department responded to 21 calls for the month of July. Mr. Borowski was less than thrilled with how last month's meeting went with the state police. Mr. Borowski was upset that the police officer didn't understand how it worked in the county, and the fact he was requested to be present at the township meeting then acted like it was a waste of his time. Mr. Borowski asked to meet with the officer outside the meeting date to talk over some details. Mr. Borowski wants to try an idea of creating a format where if there is a true emergency that involves the safety of his staff, then the right be granted to reach out to a local municipality police department to see backup.

Hereford Fire Police – Mr. Albitz reminded the board that Macungie will be holding an event that requests the fire police (Wheels of Time).
