Hereford Fire Company- Mr. Membrino announced no one was in attendance from Hereford due to a fire call during the meeting. The fire department did provide January fund balances for the BOS to review.

*Hereford Fire Police* – Mr. Albitz reported the new 2025 roster for the Hereford Fire Police along with assisting the Annual Fishing Rodeo in May. They also will be attending the event held in March for Hereford Elementary School.

**Bally Ambulance** – Mrs. Sullivan reported Hereford had 23 calls for the month of January which made up 19.3 percent of the calls for the month. She also reported the average billing revenue per the month of 2024 was \$48.9K. She also reported the 2025 Memberships have been mailed out, donation letters were mailed to residents living in the Borough and Bechtelsville. #### **New Business**

1. Action to purchase 2026 Mack Truck

Mr. Masemore mentions the funds are in the budget to purchase the 2026 Mack Truck, if the truck is paid right out the township will be saving the residents roughly \$108,000.00. Mr. Membrino really wanted to express that is why we make a budget yearly so we can plan for items in this capacity to be bought. He strongly believes because it was not budgeted for 2025 it should wait. Mr. Masemore mentioned if we finance through ESSA we will be paying roughly \$398,000.00 with a \$5,136.00 bill monthly.

Mr. Masemore made a motion to purchase the 2026 Mack truck for a total amount of \$288,179.00. Mrs. Dexter second this motion. Mr. Membrino voted against the motion. Motion passed.

Mr. Membrino mentioned he recommended having the money put back into the roads instead of purchasing a truck. A resident asked what the cost difference would be for a 6-wheel vs a 10-wheel, Mr. Membrino mentioned \$20,000.00 less. The 2026 Mack has an automatic transmission which means only 1 driver has a license to operate an automatic and not a manual transmission. Mrs. Dexter mentioned she doesn't ever want to micromanage the crew at the township and supports the request from Mr. Day. She also mentioned she is unaware of where the economy will come 6-12 months down the road and believes now would be a good time to purchase the truck. A resident also asked what will happen with the old truck that is being replaced? Mr. Masemore mentioned the money that is received will go towards the purchase value of the new truck.

- 3. Approval of Hereford Fire Police to assist East Greenville Borough with the 4<sup>th</sup> of July Fireworks at New Goshenhoppen Park.
